The chairperson opened the meeting and welcomed everyone including Wyn Ellis Jones for the last time.

**Minutes:** The minutes of the **13 January 2022** meeting were accepted as a true record, proposed by Dylan Davies and seconded by Eryl Owain.

## Materion yn codi:

**Cyfoeth Naturiol Cymru:** Adroddwyd y bydd CNC yn cynnal dwy sesiwn galw heibio yn Neuadd Ty'n-y-Porth ddydd Mawrth 22 Mawrth lle byddant yn esbonio'r cynllun gwaith coedwig am y flwyddyn i ddod.

Teimlwyd yn gryf y dylai CNC ddechrau adeiladu'r ffordd goedwig newydd y maent wedi bod yn addo ei hadeiladu.

**Toiledau Cyhoeddus: Paneli solar / System Mynediad / Offer Trydanol:** Adroddwyd bod y Clerc wedi cofrestru'r paneli solar gydag SP Energy a'i fod bellach yn aros i EON dderbyn ffurflen gais y Warrant Allforio Clyfar (SEG).

Adroddwyd bod y Cyngor Sir wedi ychwanegu'r fynedfa i'r toiledau at eu contract cynnal a chadw yn gyfnewid am ffi fach ac maent yn cynghori'r Cyngor Cymuned i drefnu archwiliad trydanol bob pum mlynedd.

Adroddwyd hefyd bod y golau 'toiled prysur' wedi rhoi'r gorau i weithio. Cysylltir â thrydanwr.

Credid bod angen gwneud taliad i'r neuadd mewn cysylltiad â glanhau'r toiledau cyhoeddus.

**Wal Mynwent Arwelfa:** Adroddwyd bod y Clerc yn dal i aros am bris gan un o'r contractwyr. Bydd Geraint Thomas yn ei ffonio.

## Materion ffyrdd:

**Pont yng nghanol Penmachno:** Adroddwyd y bydd y Cyngor Sir yn trwsio'r bont yn fuan. Bydd hyn yn golygu symud craen ar y bont a bydd yn achosi oedi hir am un diwrnod. Y gobaith yw y bydd y gwaith yn cael ei wneud ar ddydd Sul er mwyn achosi'r aflonyddwch lleiaf i draffig.

**Cerbydau'n Goryrru – Ffordd Ysbyty:** Mae'r Cyngor Sir wedi cwblhau arolwg cyflymder. Cofnodwyd 693 o gerbydau ond nid oedd yr un ohonynt yn goryrru. Credid y gallai lleoliad yr offer fod wedi effeithio ar y canlyniadau.

**Llwybr Pigin Esgob:** Mae CNC wedi dweud mai'r Cyngor Sir sy'n gyfrifol am y trac. Mae'r mater wedi'i adrodd i'r Cyngor ond ni chafwyd ateb eto.

## Matters arising:

**Natural Resources Wales:** It was reported that NRW will be holding two drop-in sessions at Neuadd Ty'n-y-Porth on Tuesday 22 March where they will explain planned forest works for the year ahead.

It was strongly felt that NRW should begin construction of the new forest road that they have been promising to construct.

**Public Toilets: Solar panels / Door Entry System / Electrical Appliances:** It was reported that the Clerk has registered the solar panels with SP Energy and is now waiting for EON to accept the Smart Export Guarantee (SEG) application form.

It was reported that the County Council has added the entrance to the toilets onto their maintenance contract in return for a small fee and they advise the Community Council to arrange an electrical inspection every five years.

It was also reported that the 'toilet engaged' light has stopped working. An electrician will be contacted.

It was thought that a payment needs to be made to the neuadd in connection with cleaning the public toilets.

**Arwelfa Cemetery Wall:** It was reported that the Clerk is still waiting for a price from one of the contractors. Geraint Thomas will phone him.

## Road:

**Bridge in the centre of Penmachno:** It was reported that the County Council will be fixing the bridge soon. This will involve manoeuvring a crane onto the bridge and will cause long delays for one day. It is hoped that the work will be done on a Sunday to cause the least traffic disruption.

**Speeding Vehicles – Ysbyty Road:** The County Council has completed a speed survey. 693 vehicles were recorded but none of them was speeding. It was thought that the location of the equipment might have affected the results.

**Pigin Esgob track:** NRW state that the track is the responsibility of the County Council. The matter has been reported to the Council but no reply has been received yet.

**Cerbyd wedi'i adael, Stryd Llewelyn:** Roedd y Clerc yn hapus i adrodd bod y Cyngor Sir bellach wedi symud y cerbyd.

**Llys Meddyg:** Adroddwyd bod Awdurdod y Parc yn aros am wybodaeth gan y Cyngor Sir.

**Ffordd wyneb caled wedi ei hadeiladu yng Nghwm Glasgwm:** Adroddwyd bod Awdurdod y Parc wedi ysgrifennu at berchennog y tir ac yn gobeithio cael ateb yn fuan. Gellir cymryd mwy o gamau unwaith y bydd y ddeialog wedi dechrau.

**Ffordd wyneb caled wedi ei hadeiladu ar draws caeau Cae Llwyd:** Mae perchennog y tir wedi bod mewn cysylltiad â'r Clerc ac mae'n credu bod ganddi ganiatâd ar gyfer y trac. Mae Awdurdod y Parc yn ymwybodol o hyn ac yn gobeithio cwrdd â pherchennog y tir yn fuan i ddatgelu ai'r hyn sydd wedi'i adeiladu yw'r hyn a ganiatawyd. Yn dilyn hyn, bydd Awdurdod y Parc yn gweld pa gamau, os o gwbl, sydd angen eu cymryd.

**Adeilad yn cael ei godi ym mhen pellaf maes parcio hen westy'r Machno:** Mae Awdurdod y Parc wedi ymweld â'r safle ac yn ymwybodol o'r hyn sy'n digwydd. Maent wrthi'n ysgrifennu at y perchennog i gael rhagor o wybodaeth a thrafod unrhyw oblygiadau cynllunio.

## Gohebiaeth

**Flint Bishop:** Adroddwyd bod NPower, am ryw reswm, wedi penderfynu rhoi'r hen gyfrif trydan ar gyfer y toiledau cyhoeddus yn nwylo casglwyr dyledion yn hytrach nag anfon y bil at y Clerc. Maent bellach wedi cadarnhau bod y mater wedi'i ddatrys.

**Un Llais Cymru:** Penderfynwyd parhau fel aelodau.

**Cae Llwyd:** Roedd y Clerc wedi derbyn dau e-bost gan berchennog Fferm Cae Llwyd: y cyntaf yn esbonio'r sefyllfa gyda'r trac a'r ail yn gofyn am gefnogaeth y cyngor gyda chais cynllunio sydd ar hyn o bryd yn y cam cyn ymgeisio. Penderfynwyd aros i'r cais gael ei gyflwyno'n ffurfiol a nododd nad yw'r Cyngor Cymuned yn gallu gwneud unrhyw beth tan hynny.

**E-byst gan etholwr:** Adroddwyd bod y Clerc wedi derbyn sawl e-bost gan Mr Martindale a hoffai i'r cadeirydd gael ei ofyn nifer o gwestiynau:

1. *Pryd wnaethoch chi ymuno â'r cyngor am y tro cyntaf fel cynghorydd i Gwm Penmachno?*
2. *A gawsoch eich ethol drwy bleidlais gymunedol neu a gawsoch eich cyfethol gan y Cyngor Cymuned?*
3. *Pryd wnaethoch chi ennill etholiad diwethaf i gynrychioli Cwm Penmachno?*

**Abandoned vehicle, Llewelyn Street:** The Clerk was happy to report that the County Council have now removed the vehicle.

**Llys Meddyg:** It was reported that the Park Authority are waiting for information from the County Council.

**New track / road laid in Glasgwm Valley:** It was reported that the Park Authority had written to the landowner and hoped to receive a reply soon. Further steps can be taken once the dialogue has begun.

**New track / road built across Cae Llwyd fields:** The landowner has been in contact with the Clerk and believes that she has permission for the track. The Park Authority is aware of this and hopes to meet with the landowner soon to check whether what has been built matches what was permitted. Following this, the Park Authority will identify what action, if any, needs to be taken.

**Building erected at the far end of the Machno Inn car park:** The Park Authority has visited the site and is aware of what is happening. They are in the process of writing to the owner for more information and to discuss any planning implications.

## Correspondence

**Flint Bishop:** It was reported that, for some reason, NPower had decided to put the old electricity account for the public toilets in the hands of debt collectors instead of sending the bill to the Clerk. They have now confirmed that the matter is resolved.

**One Voice Wales:** It was decided to continue membership.

**Cae Llwyd:** The clerk had received two emails from the owner of Cae Llwyd Farm: the first explaining the situation with the track and the second asking for the council's support with a planning application which is currently at the pre-application stage. It was decided to wait for the application to be submitted formally and noted that the Community Council is unable to do anything until then.

**Emails from a constituent:** It was reported that the Clerk had received several emails from Mr Martindale who would like the chairperson to be asked several questions:

1. *When did you first join the council as a councillor for Cwm Penmachno?*
2. *Were you elected by community vote or were you co-opted by the Community Council?*
3. *When did you last win an election to represent Cwm Penmachno?*
