Elusen Plwyf Penmachno

Croesawodd y Cadeirydd adroddiad gan Elusen Plwyf Penmachno. Dywedodd Dylan Davies, Cyngorydd Cymunedol ac Ysgrifennydd yr Elusen, fod yr elusen wedi gallu rhoi sawl grant eleni gan gynnwys i Ti a Fi, yr Hen Ysgol, Ty'n y Porth a phrosiect WiFi cymunedol. Gwesty'r Machno: Adroddwyd bod y mater hwn bellach yn nwylo Awdurdod y Parc Cenedlaethol a bydd diweddariad pellach yn fuan.

Llys Meddyg: Penderfynwyd cysylltu â'r adran priffyrdd eto ynglŷn â'r mynediad peryglus newydd i'r eiddo.

Llwybr Cyhoeddus 55: Pen-y-Waen - Stryd Llewelyn: Adroddwyd bod y Cyngor Sir, yn dilyn cyfarfod safle cynhyrchiol iawn, wedi cysylltu ag Openreach, trefnu i drwsio'r palmant, a gofyn am fin graean.

Sgipiau: Adroddwyd bod y Cyngor Sir, ers sawl wythnos, wedi anwybyddu ceisiadau am sgip cymunedol ar gyfer y ddau bentref ac yna methu yn eu dyletswydd i ymateb yn Gymraeg. Penderfynwyd mynd â'r mater ymhellach.

Plas Isaf: Adroddwyd bod Cymdeithas Tai Gwynedd yn gobeithio cael y tŷ yn barod yn ddiweddarach eleni i'w osod i deulu Cymraeg lleol. Penderfynwyd rhoi gwybod i'r perchnogion am arogl olew y tu allan i'r tŷ.

Declaration of interest

There were no declarations

Confirmation of the minutes

The minutes of the **13 March 2023** meeting were accepted as a true record, proposed by Claire Roberts and seconded by Wil Edwards.

Penmachno Parish Charity

The Chair welcomed a report by Penmachno Parish Charity. Dylan Davies, Community Councillor and Charity Secretary, reported that the charity had been able to give several grants this year including to Ti a Fi, the Old School, Ty'n y Porth and the community WiFi project. It was reported that the current farm tenancy agreement comes to an end next year.

Matters arising

Arwelfa Cemetery Wall: The Council unanimously accepted one of the quotes. It was decided to continue the search for funding.

Lorries in Cwm Penmachno: It was reported that the Welsh Government is looking into replacement signs on the A5.

Community WiFi: It was reported that the chapel and the Old School will be the next buildings to connect to the community WiFi.

Machno Inn: It was reported that this is now in the hands of the National Park Authority and a further update will be provided soon.

Llys Meddyg: It was decided to contact the highways authority again regarding the dangerous new access to the property.

Public Footpath 55: Pen-y-Waen - Stryd Llewelyn: It was reported that, following a very productive site meeting, the County Council had contacted Openreach, arranged to fix the pavement, and requested a grit bin.

Skips: It was reported that the County Council had, for several weeks, ignored requests for a community skip for both villages and then failed in their duty to reply in Welsh. It was decided to take the matter further.

Plas Isaf: It was reported that Cymdeithas Tai Gwynedd hope to have the house ready later this year to let to a local Welsh family. It was decided to let the owners know about a smell of oil outside the house.

Toiledau cyhoeddus: Adroddwyd bod grant ar gyfer system fynediad newydd yn dal i gael ei ymchwilio.

Gohebiaeth

Siop Penmachno: Cafwyd cwyn am barcio anystyriol a cherbydau yn aml yn rhwystro'r ffordd. Penderfynwyd defnyddio posteri a chyfryngau cymdeithasol i annog pobl i barcio mewn lleoliad priodol. Hefyd, adroddwyd bod ymwelwyr weithiau'n llenwi biniau trigolion lleol gyda sbwriel ar ôl ymweld â'r siop. Penderfynwyd ysgrifennu at berchennog y siop a gofyn am ddarparu bin.

Blodau: Penderfynwyd rhoi £100 i Benmachno a £100 i Gwm Penmachno er mwyn gallu prynu blodau.

Gwrychoedd Bron y Waen: Penderfynwyd gofyn i Cartrefi Conwy dorri'r gwrychoedd, sy wedi gordyfi.

Torri Gwair: Penderfynwyd cysylltu â'r Cyngor Sir eto yn dilyn y safon wael iawn o dorri gwair.

Public Toilets: It was reported that a grant for a new entry system is still under investigation.

Correspondence

Penmachno shop: A complaint had been received about inconsiderate parking and vehicles frequently blocking the road. It was decided to use posters and social media to encourage people to park appropriately. Further it was reported that visitors sometimes fill local residents' bins with rubbish after visiting the shop. It was decided to write to the owner of the shop and ask for a bin to be provided.

Financial Report

It was noted that there was £9,220.86 in the bank.

The following bills were paid: HSBC £16, Dŵr Cymru £86.95, EON £24, Google £9.20, BT £30.40, Un Llais Cymru £160, BHIB (insurance) £420.65, Clerc (wages) £1,387.05, Clerc (defnydd cyfrifiadur) £25

The following was paid in: Conwy CBC (precept) £2,500, G&MJ Cameron £50

The accounts for 2022-23 were confirmed as correct. The annual audit form was signed by the chairperson. It was decided to send the accounts to J. Llywelyn Hughes in Llanrwst as usual for the internal audit.

Other matters

Bron Graig: It was reported that water is still flooding the road.

Blaen Cwm: It was reported that the road is in a bad state of repair.

Flowers: it was decided to donate £100 to Penmachno and £100 to Cwm Penmachno so that flowers can be bought.

Hedges Bron y Waen: It was decided to ask Cartrefi Conwy to cut the hedges, which are overgrown.

Grass Cutting: It was decided to contact the County Council again following the very poor standard of grass cutting.
