Confirmation of the minutes

The minutes of the **09 Mai 2023** meeting were accepted as a true record, proposed by Eryl Owain and seconded by Claire Roberts.

Matters arising:

Lorries in Cwm Penmachno: It was reported that lorries were still causing a problem including NRW contractors. It was decided to write again to the Welsh Government, the County Council and NRW.

Community WiFi: It was reported that equipment has been purchased to connect the chapel and the Old School; the Clerk was trying to find enough time to carry out the installation.

Machno Inn: It was reported that the landowner has been served with a Section 215 Notice and has until October to clear the site.

Llys Meddyg: It was reported that the landowner claims to have reopened a preexisting vehicular access to the highway. It was decided to contact the County Council providing evidence to the contrary.

Skips: It was reported that two skips had been ordered: 01 August, Penmachno and 02 August Cwm Penmachno.

Public Toilets: It was reported that the entry system is broken. All documents had been prepared for a grant application including three letters of support from the community. The quote from *Hi-Tec Washrooms* was accepted.

Ysgwyfrith: It was reported that the National Trust hope to have the property ready for September.

1. A fyddai'r Cyngor Cymuned yn cefnogi trosi Capel Bethania i dai preswyl?
2. Oes gan unrhyw un syniadau ar gyfer defnyddiau amgen ar gyfer y capel ar wahân i dai?

Ymateb y Cyngor oedd:

1. Ni fydd y Cyngor yn gwneud asesiad heb weld cynlluniau penodol.
2. Nid oes gan y Cyngor sylw ar y mater hwn.

Mesurau Tawelu Traffig: Adroddwyd bod y Clerc wedi derbyn manylion am farciau ffyrdd newydd i helpu arafu traffig ar ddechrau'r parth 30mya rhwng yr A5 a Phenmachno.

Archwiliadau: Adroddwyd bod Archwilio Cymru wedi gorffen yr archwiliadau ar gyfer 2019 a 2021. Derbyniwyd rhestr hir o geisiadau am wybodaeth ynghylch archwiliad llawn cyntaf y Cyngor.

Cerdyn Debyd: Cytunwyd yn unfrydol y dylai'r Clerc gael cerdyn debyd.

Correspondence

Red Telephone Box: It was reported that the Clerk had received a lot of correspondence about the removal of the last telephone box in the village which was being used as a library but had not been adopted by the community.

Mobile Telephone Mast: It was reported that a company is still trying to find a suitable location for a mobile telephone mast in the centre of the village.

Capel Bethania: It was reported that a resident of Penmachno had asked for two questions to be put to the Council:

1. Would the Community Council support the conversion of Capel Bethania to residential housing?
2. Does anyone have ideas for alternative uses for the chapel apart from housing?

The Council's response was:

1. The Council will not make an assessment without seeing specific plans.
2. The council has no comment to make on this matter.

Traffic Calming Measures: It was reported that the Clerk had received details about new road markings to help slow traffic at the start of the 30mph zone between A5 and Penmachno.

Financial Report

It was noted that there was £8,709.82 in the bank.

Audits: It was reported that Audit Wales have finished the audits for 2019 and 2021. A long list of requests had been received regarding the Council's first full audit.

Debit Card: It was agreed unanimously that the Clerk should have a debit card.

Llwybr Cyhoeddus 64: Adroddwyd am broblemau amrywiol gyda rhwystr posibl o'r llwybr hwn. Penderfynwyd ymchwilio ymhellach ac adrodd y mater i'r Cyngor Sir.

Asesiad Risg Mynwentydd: Penderfynwyd cynnal asesiad risg yn y mynwentydd ar 18 Gorffennaf.

Trelar: Adroddwyd y gallai trelar sydd wedi'i barcio yng Nghwm Penmachno beri perygl, yn enwedig i blant. Penderfynwyd adrodd y mater i'r Heddlu ac Awdurdod y Parc.

Other matters

Laminated Posters: It was reported that laminated posters stapled to telegraph poles can be dangerous to livestock. It was decided to repair the Council's notice boards and advise people to make use of them.

Stray Dog: It was reported that a dog is being allowed to roam free in the centre of Penmachno and causing a nuisance. It was decided to contact the authorities and the dog owner's landlord.

Public Footpath 64: Various problems were reported with a possible obstruction of this path. It was decided to investigate further and report the matter to the County Council.

Cemeteries Risk Assessment: It was decided to carry out a risk assessment at the cemeteries on 18 July.

Trailer: It was reported that a trailer parked in Cwm Penmachno could cause a danger particularly to children. It was decided to report the matter to the Police and the Park Authority.
